 doth hereby make her complaint to you
 against one Reason Halfhill for this
 that the said Reason Halfhill ever since the 5th
 day of October 1890 and does still unlawfully
 and forcibly and with a strong hand detain
 from the Possession of the undersigned the
 following Premises situate in the village of
 Hilliard Franklin County Ohio. and described as
 follows. being a one and a half story Brick
 Tenement House with about one acre of land
 bounded on the North and East by lands owned
 by W. M. Gills heirs. on the south by the Fuller
 Mill road. on the West by Joseph. Devfields lot.
 The said Reason Halfhill entered said Premises
 with the understanding that he was to pay four
 Dollars per month for the Privilege of occupancy said
 rent to be paid in advance Monthly. on the 5th of Oct.
 1890 he failed to pay said rentals. and from that

 the 27th 1890 the undersigned duly served legal
